Authors must supply an abstract of 100-150 words when submitting the article. It should be an abbreviated, accurate, representation of the content of the article. Major results, conclusions and recommendations should be given, followed by supporting, details of method, scope or purpose. It should contains sufficient information to enable readers to deduce whether they should obtain and read the entire article.

KEYWORDS: up to 5 - 8 keywords should be included which encapsulate the principal subject covered by the article.

INTRODUCTION

All the authors are asked to prepare their papers in compliance with the following guidelines. The papers should be written in English, Slovak or Czech.

The following format should be kept: a page size A4 (21 cm x 29,7 cm) spacing 1 (single), margins for the whole paper: 3,25 cm - left margin, 3,25 - right margin, 3,9 cm - top margin, 3,9 - bottom margin. The author(s) name(s) should be written on the first page as shown in Tahoma 12 pt.

The title of the paper should be written in English in Tahoma 13 pt, in bold, in capital letters. The paper itself should be written in Tahoma 10 pt. Single line spacing.

The number of pages should not exceed 8 pages of A4 (21 cm x 29,7 cm), figures, tables, references and enclosures included.

Figures, tables, and graphs should be included in the text and numbered in Arabic numerals.

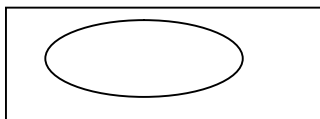


Figure 1 Text related to the figure
